					<p>During outbreaks of respiratory illnesses, internal air circulation systems will be deactivated.</p> <p>Avoid overcrowding in spaces as far as possible.</p>				
Transmission through bodily fluids.	Staff Pupils				<p>PPE (disposable gloves, disposable apron, and fluid resistant eye and mouth coverings) must be worn when providing personal care.</p> <p>PPE (disposable gloves, disposable apron) must be worn when clearing up after pupils who have vomited.</p> <p>Soiled clothing is double bagged and returned to parents upon collection of child.</p>				
Pupils bringing notifiable diseases in to school.	Staff Pupils				<p>Parents are aware of the process for reporting sickness absence.</p> <p>Parents are aware of the requirement to contact the school for advice if they suspect their child has a notifiable infectious disease.</p>				

					<p>Process in place for contacting parents and sending pupils home if they are suspected to have a notifiable disease.</p> <p>Exclusion from school is applied in line with guidance in “The Spotty Book”</p>				
Cleaning	Staff				<p>Disinfectants and cleaning substances are stored, mixed and used in line with manufacturer’s instructions.</p> <p>COSHH assessments are completed for cleaning materials.</p> <p>Cleaning is completed in line with guidance in “The Spotty Book”</p>
